**TOTAL HOLDER DISPLAY**

TRAN\*STAR's Individual Holder Display lets you identify for a particular registration any issue on your database which has ever had certificates held in that name. The report provides the issue names, the certificate numbers held, the issue date, the cancellation date if applicable and the denomination. If applicable, the report displays book entry positions.

In addition to holdings, the display also provides complete payment history for the holder for each issue ever held. Payment detail includes check number, date issued, date cashed, net dollar amount and, if applicable, deductions.

The display may be limited to include only outstanding certificates (or all certificates) book-entry totals (or detail of transactions) uncashed checks (or all checks) and proxy voting history.

**DETAILED HOLDER LIST**

## LOOK-ALIKE SHAREHOLDER REPORT

If you have more than one holder on your database with the same or similar names, TRAN\*STAR's Look-Alike Shareholder Report will tell you. The "Look-Alike" feature compares the registration name, the registration type, the first address line, the city and zip code, the Tax ID and the way the name sounds, to determine whether to include a name on the Look-Alike Shareholder Report.

The Look-Alike Shareholder Report allows you to identify situations where you need to use the system's "Consolidate Holder" activity. The report will also allow you to identify shareholders with similar names, similar shareholders with different Tax ID numbers, shareholders with more than one address and shareholders who hold securities in various capacities (as custodian and trustee, for example). It can also help you identify possible errors. For example, if you have set up a shareholder record with transposed numbers in a Tax ID or in an address, the report will allow you to identify the error.

**TRANSFER JOURNAL**

TRAN\*STAR's Transfer Journal is a comprehensive record of each transaction. Surrendered and canceled certificates are listed in the left-hand column as debits, issued certificates are listed in the right-hand column as credits.

Details for a debit include: the previous holder's name, address, Tax ID number, account number, certificate number(s), number of pieces and denomination, with total shares or par value being canceled. Details for a credit include: the new holder's name, address, Tax ID number, account number, certificate number(s), number of pieces and denominations, with total shares or par value being issued.

If you are processing book entry transactions, the Transfer Journal will show debits and credits with the legend "Book Entry".

If a Tax ID number has not been supplied, the Journal reports it as "missing TIN". If it has been requested but not received, it is reported as "applied for".

You can produce Transfer Journals by issue, issuer, all issues, a specific date or date range. If you produce by all issues, the Transfer Journal pages are broken by issue. If you produce by a date range, the pages are broken by calendar day.

**TRANSMITTAL LETTER**

TRAN\*STAR can produce a Transmittal Letter to be enclosed with certificates that are to be mailed. If you do not print addresses on certificates, then this transmittal letter can be used to indicate the mailing address in a window envelope.

This Transmittal Letter is completely free-form. It is set to your specifications in TRAN\*STAR's template builder, EDTEMP.

Transmittals may be generated using either cut-sheet "letters" or continuous form documents.
